## Items Discussed/Proposed for Fall 2020:

The UP Advisory/Steering Committee discussed potential pros and cons of increasing UP student acceptance/enrollment rates in order to better reflect the increased WCU student enrollment and to accurately represent the 0.1% prevalence of intellectual disability (ID) within our WCU community.

A motion and second from committee members was made with approval from members present in favor of increasing UP student enrollment from 8 to a total of 12 students (reflecting the 0.1% representation of the 12,000 WCU student enrollment). It was also discussed that UP students would have the option (like other WCU students to live in off-campus housing if needed) if on-campus housing was not approved beyond the 8 beds currently designated for UP students with WCU Residential Living for Fall 2020/Spring 2021.

Fall 2020 UP applicants were then reviewed and ranked individually with their submitted admission materials/videos for the remainder of the meeting.

Due to COVID-19, the UP Advisory Board/Steering Committee did not meet again in the Spring 2020 semester.
