## **Overnight Youth Camp Rules and Acceptance Form**

- 1. I understand that lost room keys are \$50.00 each and lost access/meal cards are \$35.00 each. Removal or damage to window screens or throwing objects from windows result in a minimum \$25.00 fine.
- 2. Cell phones and audio devices such as ear buds, etc should not be used during scheduled programs & activities.
- 3. Campers MUST obey directions of staff and camp counselors at all times.
- 4. Campers are to remain in the residence hall each evening after evening activities (no later than 11:00 PM) until 7:00 AM the next morning unless otherwise directed.
- 5. No student should enter the room of any camper of the opposite sex at any time. No exceptions.
- 6. Shirts and shoes are required at all times. Campers are expected to wear proper attire to all events. Students must be fully clothed when outside of the sleeping room in the residence hall.
- 7. Fans, lights, and other electrical appliances should be turned off when campers leave their rooms.
- 8. Room assignment changes will not be permitted unless approved by the Camp Director or designated representative.
- 9. Campers are expected to attend all activities and report to activities on time.
- 10. Campers are not permitted to leave campus at any time without authorization from the Camp Staff.
- 11. Possession or consumption of alcoholic beverages, illegal drugs, or tobacco products will result in immediate dismissal.
- 12. No guns, knives or any item that may be considered a weapon is allowed. Any student found in possession of such items will be dismissed immediately.
- 13. No malicious pranks, disrespectful behavior, or abuse either verbal or physical will be tolerated. Parents may be requested to remove their child from the program if any of these occurrences are observed or reported. Respectful behavior toward other campers and counselors will always be observed.
- 14. In case of injury or illness, or other emergency, notify camp staff immediately.
- 15. Although premature program departure is discouraged, leaving the camp early must be coordinated through the camp staff. No one should leave without permission at any time.
- 16. Campers will be allowed to leave the residence hall on check out day only with a **previously authorized person.**
- 17. Keep doors locked at all times, particularly when out of the room. Do not prop exit doors open.
- 18. Room furnishings may not be disassembled and moved to other locations. Public area furniture may not be moved. Moving or otherwise tampering with furnishings will result in a fine.
- 19. Although noise levels should always be monitored, special attention to minimizing noise should be observed between the hours of 11:00 PM and 7:00 AM. Lights out is at 11:00. We share the residence hall with others and must be respectful of their needs.
- 20. By signing below, campers are agreeing to abide by these and all Staying-On-Campus Policies as found on WCU's website at <a href="http://camps.wcu.edu">http://camps.wcu.edu</a>.

Violators of these regulations may be subject to immediate dismissal. Parents will be called to arrange for camper's return transportation. Violations of a less severe nature may result in restriction of campers from social activities.
