WHEREAS the Faculty Senate approved a resolution from the Collegial Review Council (CRC) on 24 March 2021 requiring a current CV for 1<sup>st</sup>, 3<sup>rd</sup>, and 5<sup>th</sup> year TPR candidates; and

WHEREAS current guidelines do not require a CV for candidates undergoing 2<sup>nd</sup>, 4<sup>th</sup>, and 6<sup>th</sup> year reviews; therefore

BE IT RESOLVED, the CRC recommends that the Office of the Provost require a current CV for 2<sup>nd</sup>, 4<sup>th</sup>, and 6<sup>th</sup> year TPR candidates and update the *Guidelines for Preparation of Application/Dossiers for Tenure, Promotion and Reappointment* accordingly.
