ACADEMIC BIO

I am currently Professor of English at Western Carolina University teaching medieval British literature, research methodology, and professional writing courses. Since arriving at WCU in 1998, I have served as Director of the Professional Writing Program, Director of the Literature Program, Coordinator of the Spring Literary Festival, Department Head in English, Associate Dean of the Graduate School, and Provost Fellow (an Interim Associate Provost position). My scholarship focuses upon mercantile rhetoric in later medieval English literature, especially in the texts of John Gower, Geoffrey Chaucer, and Margery Kempe. I am co-editor of, among others, the *MLA Approaches to Teaching the Poetry of John Gower* (2011) and *The Routledge Research Companion to John Gower* (2017), and I have authored a number of articles and chapters, and presented repeatedly at national and international conferences, on the texts of Gower, Chaucer, Margery Kempe, and others. Having served as WCU's SACS Reaffirmation Report Editor, I have also worked on numerous departmental and institutional assessment projects and have run multiple workshops on writing accreditation report and compliance documents for the Southern Association of Colleges and Schools – Commission on Colleges (SACS-COC). In 2018, I was the recipient of WCU's University Scholar Award, and in 2020 I received the Jon Hurt Fisher award from the John Gower Society.

ADMINISTRATIVE AND RELATED EXPERIENCE

Provost Fellow [Acting Associate Provost], Western Carolina University (July 2013 – July 2014)

During an ongoing search for a permanent Provost, WCU appointed a set of Provost Fellows in lieu of an interim Associate Provost. As Provost Fellow for Faculty Development, I was responsible for all faculty and faculty-dataset issues related to the Associate Provost position for a university with 10,000+ students (approximately 8,000+ UG and 2,000+ GR) and 600+ faculty. Duties included:

- Oversight of the Annual Faculty Evaluation AFE, Collegial Review (Tenure, Promotion, and Reappointment), and Post-Tenure Review processes
- Professional Development for Department Heads (including supervision of Department Head Workshops)
- Coordination of the Associate Deans' Council
- Oversight of the Chancellor's Travel Fund award (\$150,000)
- Oversight of the Faculty Handbook—especially in relation to faculty employment and responsibilities
- Coordination of the Scholarly Development Assignment (“sabbatical”) process
- Responding to UNC General Administration as needed, including
 - Faculty Workload recommendations and reports
 - Management Flexibility reporting
 - Class Size and Instructional Efficiency Task Force

Further duties including assisting the Provost Office with the development of New Faculty Orientation agendas, Distinguished Professor networking support, representation on Council of Deans as agenda warranted, liaison with the Collegial Review Council and Faculty Affairs Council of Faculty Senate, and representing faculty issues with WCU Board of Trustees.

Department Head, English, Western Carolina University (July 2009 – Dec 2012)

Administrative officer in charge of faculty, staff, curriculum, and budget for a department that included 30 faculty, four undergraduate concentrations (180-220 majors in English Literature, Professional Writing, Motion Picture Studies, and English Education), six undergraduate minors, four graduate degrees (70-90 students – MA with concentrations in Literature, Professional Writing, and Comp/Rhet; MAEd; MAT; MA TESOL). Key accomplishments include:

- Implemented an evaluative model of personnel/faculty performance
- Scheduled classes to meet increased capacity (with university growth approaching and SCH targets while retaining 3-course load for professorial faculty)
- Supported faculty scholarship through course load and work load management to allow faculty to be more productive
- Developed model for graduate TA use that increased instructional efficiency
- Worked closely with Registrar's office on university-wide initiatives such as degree audit, graduation checkout, transfer articulation, student progress reporting, and projecting course/seat demand

- Managed summer course offerings to increase departmental profit sharing from less than \$100 (the summer prior to my arrival as department head) to almost \$5000 in 2010, with total net profit to the institution rising from a \$1000 loss the year prior to my arrival as DH to over \$60,000 profit to the institution in 2011.
- Prepared program prioritization reports for all concentrations
- Supervised preparation of annual assessment reports
- Fostered and supported engaged teaching learning initiatives in courses and programs at all levels, including an annual student-run literary conference, undergraduate research, internships/co-ops, and the department's Spring Literary Festival

In this position I managed to secure funding from multiple sources to support virtually all faculty research/travel requests. Budgeting management includes oversight of a State budget as well as endowment funds and other non-state-appropriation accounts.
