## **Experiential and Outdoor Education (M.S.)**

### **EOE - 621 - Introduction to Environmental Interpretation**

Currently there is a list of EOE electives that limits student choice when the program degree requirements allow students to take any graduate level electives in the EOE program OR any other program at WCU. We need to remove this list so that we do not have over rides when students take a course not currently populated on this list. This was an error when the program was initially established in the catalog.

EOE 621 The undergraduate course cross-listed with this course had a title and course description change that was already approved through Curriculog last year. We need to update the EOE graduate course with the same changes.

## **Educational Leadership (Ed.D.)**

### **Course Name Changes**

#### **EDL - 893 - Topics in Educational Leadership**

Deleting and adding courses to the mix - EDRS 800 is not taught, we offer EDRS 895 instead as it better prepares students for the disquisition.

EDL 893 - Students need to be able to complete up to 9 credits in this course.

## **Education - Comprehensive Education (M.A.T.)**

### **Program and Course Changes**

- 1) The concentration in Art is being deleted because there are changes in state licensure requirements that need to be addressed before students can be admitted to the concentration.
- 2) The change proposed for the section on Requirements for Teacher Licensure is being updated to reflect a recent CEAP licensure policy change, to better align with state licensure policy and to clarify WCU's role in the licensure process.
- 3) The prerequisite changes are needed because a course is identified as the internship 1 course and the other courses no longer need prerequisites.
- 4) The number of SPED 506 is changed to SPED 585 because this course is now an intern 1 course.

## **Public School Leadership (Post Master's Certificate)**

We want to reactivate the Public School Leadership Post Master's Certificate (PMC) due to changing state requirements. Last year we deactivated this PMC based upon the North Carolina Department of Public Instruction starting to enforce NC State Law G.S. 115-284 which required principal licensure pathways to include earning a Masters in School Administration (MSA). However, in July 2022 the state gave a waiver through Fall 2024 for G.S. 115C-284. Discussions within the Professional Educator Preparation and Standards Commission (PEPSC) and NC State Board of Education are recommending that PMC programs that lead to principal licensure continue. To stay competitive with others and to prepare qualified educators to be principals for our region, we need to reactivate our program. We would like to reopen admissions as soon as possible and for accepted students to begin in courses in Fall 2023.

## **Social Work (M.S.W.)**

## Course Change

SOCW 586 - Foundation Field Practicum and Seminar

SOCW 596 - Foundation Field Practicum Seminar

Combining 586 and 596 into one course of equal credit = 8. This is typical of social work programs that this is one course, thereby giving faculty 1 course responsibility versus 2 courses.

Adapted curriculum program description change - The wording for the Requirements for Teacher Licensure is being updated to reflect a recent CEAP licensure policy change, to better align with state licensure policy and to clarify WCU's role in the licensure process.

1) SPED 506 is being changed to SPED 585. SPED 585 is now an intern 1 course.

2) The wording for the Requirements for Teacher Licensure is being updated to reflect a recent CEAP licensure policy change, to better align with state licensure policy and to clarify WCU's role in the licensure process.

SPED 501, 502, 503, 566, 605, 630 **Deletions** - This course is not used by the special education program. The special education program is cleaning out old courses from the catalog.

SPED 562, 563 - The prerequisite is being removed from this course because an intern 1 course is now identified.

SPED 585 - SPED 506 has been identified as an Internship 1 course, a title change and a prerequisite are needed. Since this course is now an internship course the number needs to change to SPED 585 to align with WCU's policy on course numbers.

SPED 587 - SPED 506 needs to be removed from the prerequisite and SPED 585 needs to be added.

SPED 633 - This course will now be offered to students completing the certification program and the prerequisite is no longer needed.

## Financial Assistance

The Financial Assistance Committee had no additional information to report. The Financial Assistance Committee will review summer assistantship application in March.

## Dean Report

### Graduate Enrollment Summary

- Census Report

The Spring 2023 Census Statistics Report was distributed to the Graduate Council.

We have 1,568 of our graduate students enrolled accounting for 13,461 SCHs for Spring 2023. We are down 129 graduate students enrolled, point in time, compared to Spring 2022 and graduate student credit hours are down 1,036 SCHs, point in time, compared to Spring 2022. Total WCU registration for Spring 2023 is 10,586 students accounting for 131,050 student credit hours

- Weekly Summary

The Spring 2023 Census weekly summary was distributed to the Graduate Council.

### Graduate Tuition Increase Update

A 3% graduate student tuition increase has been proposed, and the estimated increase in revenue is \$253,000. If approved, the tuition increase will be effective for the 2023 fall term. A draft budget proposal was prepared and includes a plan to allocate the additional funding. Funding cannot be allocated until the funds are collected.

The proposal was presented to the Board of Governors. The Board of Governors will follow up and vote in late February.

## Associate Dean Report

### March 22-23, 2023 Research and Scholarship Conference (RASC) and Graduate Research Symposium updates

Graduate Council members and their students were encouraged to participate in the Research and Scholarship Conference (RASC) and Graduate Research Symposium activities.

### 2<sup>nd</sup> Annual Faculty 3MR competition

Graduate Council faculty were encouraged to participate in the 3MR competition on March 23<sup>rd</sup>. There is a prize of \$1000 and a trophy for the winner of the 3MR competition. The competition is combined with the Faculty Scholarship celebration.

## Agenda

### Discussion of student achievement metrics (Tim Metz, Assistant Vice Chancellor OIPE)

Tim Metz, Assistant Vice Chancellor of OIPE, presented institutional accreditation report information to the Graduate Council. The focus was on the “Student Achievement Measures” and “Graduation Rate” thresholds.

At a 2022 fall Graduate Council meeting the Graduate Council helped establish a minimum 75 % minimum threshold graduation rate for master’s students and 85 % minimum threshold graduation rate for doctoral students. A 95% minimum threshold for course completion rate was also established.

However, in addition to minimum thresholds aspirational goal percentages also need to be established for the graduation rate and course completion rate.

After the 6-year dashboard data was presented to the Graduate Council the aspirational goals percentages were suggested, approved by vote, and will be added to the report.

The aspirational goal for graduation rate will be 80% for master's level and 90% for doctoral level. The aspirational goal for the course completion rate will be 98%.

The links to the dashboards will be e-mailed to Graduate Council members next week. The established percentages will be revisited by the Graduate Council in the 2023 fall term after the principles are updated and changed.

### **Withdrawal Policy Changes (Kristin Daiber, Director Office of Student Retention)**

Kristin Daiber, Director Office of Student Retention, presented information about the proposed changes to the Graduate Catalog University Withdrawal policy distributed to the Graduate Council. Changes were made to align the policy with the current process and to streamline the policy. A new Section was added to the policy for "Return to Title IV."

Feedback from the Graduate Council members included deadline and refund considerations for programs with 8 week terms and use of the term program director/adviser instead of academic adviser.

### **Graduate Enrollment Task Force - Graduate Program Development**

The Graduate Enrollment Task Force was reorganized last year. Task Force members Dean Lori Anderson from the College of Health and Human Sciences and Dean AJ Grube from the College of Business updated to the Graduate Council.

Dean Lori Anderson updated the Graduate Council on the proposed Master of Science in Nursing. The proposed program "Intent to Plan" is ready to be submitted the UNC System curriculum task force.

Dean Lori Anderson also reported that the College is updating the Strategic Plan and the By-Laws.

Dean AJ Grube updated the Graduate Council on the proposed on-line Accountancy program submitted to the UNC System.

There is no update from the Task Force about the Master of Science in Engineering. There was a discussion with the College of Engineering and Technology and Administration and Finance about the College funding revolving scholarships.
