December Commencement Ceremonies

Helping Students

The end of an academic semester can be stressful for our students. We encourage faculty and staff to make a referral if you notice an issue with a student, whether it's academic, non-academic, or both. By addressing students' needs early, appropriate interventions can help empower them to make choices that positively impact their academic success. Student concerns are addressed in two separate but related processes depending on whether the student concern is academic or non-academic in nature.

- Academic concerns are managed via Navigate, a web-based tool which WCU uses to coordinate, target, and report on advising, tutoring, and other student success services. Navigate can be accessed in myWCU.wcu.edu by clicking on the link for Advising/Tutoring.
- Non-academic concerns are managed in the online platform, Maxient. Faculty, staff, students, family members, or anyone with a non-academic concern about a student can submit their concern via Maxient. The form can be accessed via scrt.wcu.edu.

If there is any confusion as to which platform to submit your concern, you may submit it in either. All concerns will be routed to the appropriate place once submitted. Thank you to all faculty selected to offer Service-Learning designated courses in the spring semester. A list of approved courses is available at this <u>link</u>.



NSSE Administration in Spring 2024

Every three years, WCU participates in the National Survey of Student Engagement (NSSE). Initiated in 2000, NSSE is housed within the Center for Postsecondary Research (CPR) in

the Indiana University School of Education. Hundreds of four-year colleges and universities participate each year. NSSE is targeted to first-year and senior students' and focuses on participation in college programs and activities related to learning and personal development. The survey will launch on February 21st

Interpretive Exhibits of EBCI History and Culture on Campus



Last Spring, WCU was awarded a \$40,000 grant from the Cherokee Preservation Foundation to support the development of a comprehensive plan for adding interpretive exhibits on campus that both teach about and celebrate the history and culture of the Eastern Band of Cherokee Indians. The project is being led by Dr. Carmen Huffman, Interim Associate Provost, Dr. Brett Riggs, Sequoyah Distinguished Professor of Cherokee Studies, and Denise Drury Homewood, Executive Director of the Bardo Arts Center. The aim of the project is to plan for interpretive exhibits and interactive displays that would educate the

campus and its visitors about the campus's historical Cherokee presence as well as the culture of the Cherokee people, both past and present. With additional financial support from the Offices of the Chancellor and Provost, we have partnered with HW Exhibits to shepherd the design process. The firm will host a virtual kickoff meeting in January with the steering committee, comprised of faculty in the Cherokee and Indigenous Studies program, select staff, and EBCI partners. An on-site visit is scheduled for later in the Spring 2024 semester. Stay tuned for opportunities to share ideas in open forums in the spring.

Faculty Workload Reporting Policy - System Level

The draft regulation (400.3.4[R]) was distributed to Faculty Senate and the deans for feedback, which has been shared with the System Office. More details to follow.

Carnegie Classifications Update 2025

The Carnegie Classification of Institutions of Higher Education is now partnered with the American Council on Education (ACE) and serves as the leading framework for categorizing 4,000 higher education institutions in the United States. In preparation for the release of a new classification methodology in 2025, the framework is undergoing extensive review, including more multidimensional categories instead of the current single dimensions.

Extended Winter Closing

The University will be closed from Monday, December 25, 2023 through Monday, January 1, 2024, with all six business days being Holidays. No additional leave days will be required of employees.

This schedule will enable the University to lower building temperatures during the closing and, thereby, achieve significant energy savings. Building temperatures, except in areas where research or other essential operations require
