
#### **Faculty Relations Fellows**

#### Advising Day Survey Results

The 2023 Advising Feedback Survey, conducted with 686 student respondents, reveals key insights into course registration for the Spring 2024 semester. Notably, 87% of participants have completed their course registration, while 13% have not. For those not registered, reasons vary, with 31% planning to register, 26% citing other reasons, and 26% indicating completion of graduation requirements as reason they have not registered. Challenges in meeting advisors were reported by 11%, with issues ranging from scheduling difficulties to miscommunications. The majority, however, rated their advising experience positively (78% rated as Excellent or Good). The survey also highlighted positive outcomes of their advising sessions, such as 97% receiving alt-pins and 75% being reminded of their registration start time. Challenges during registration were minimal, with 59% reporting no issues. Overall, the Spring 2024 course registration experience received positive ratings, with 71% rating it as Excellent or Good. Additionally, 41% of respondents expressed interest in advisor outreach for further assistance.

# Liberal Studies – Student Learning Outcomes and Assessment



Our Liberal Studies curriculum consists of approximately 250 courses/sections, and its size means that it touches almost every undergraduate student experience and almost every academic department at the university. The program conducts on-going assessment of student learning around the 10 outcomes approved by faculty and shares the results in an annual assessment report published on the Liberal Studies Assessment website. Additional resources such as liberal studies course

development, and the assessment plan, including outcomes' definitions and rubrics, etc., are also available at the website.

We extend deep appreciation to the 95 faculty members who submitted student artifacts as part of the fall liberal studies assessment--an expectation of teaching in the program. The Liberal Studies Assessment Director notifies faculty the semester before their course is to be included in Liberal Studies assessment to allow time to include an assignment that aligns with the LS outcome being measured. Then, at the beginning of the semester in which artifacts will be collected, the assessment director provides detailed artifact submission instructions and support for artifact creation and submission. For spring 2024, problem solving, diversity, and inclusion, will be assessed; critical thinking will be assessed in fall 2024. # **UNC System Financial Literacy Survey**

The UNC System Financial Literacy and Wellness Working Group has been established to create a comprehensive set of resources, models, support tools and a recommended plan for financial

literacy and wellness program/resource development at its member institutions. Last year the UNC System Financial Literacy and Wellness Working Group conducted a survey that gathered information about the different types of financial literacy and wellness programs and models that were being employed across the UNC System. This information helped the Working Group establish a baseline for setting priorities by increasing understanding of financial wellness programs and activities in place at your institution.

This January, the Working Group is surveying all degree-seeking students across the UNC System about their knowledge of financial literacy and wellness. The students' responses will help the Working Group better understand the financial literacy and wellness needs of students at our institutions. The responses will directly impact future financial literacy and wellness programming and initiatives offered to students across the UNC System. Students will be emailed on January 12<sup>th</sup> to complete the financial literacy and wellness programs survey. Reminder emails would be sent to students on January 18, 25, and 31, with the survey closing on February 1.
